Privacy Policy

CIAL respects your privacy and this Privacy Policy describes who we are, for what purposes we use your data, how we process your data, who we share your data with, and for how long we store your data It also informs about how you can contact us and exercise your rights.

WHO WE ARE?

Your data will be processed by SOUSA E COIMBRA, LDA, legal entity no. 500275378, with registered office at Avenida da República, 14 - 2° , 1050-191 Lisboa, telephone number +(351) 217 940 448, hereafter referred to as "CIAL" or "we".

CIAL is the data controller within the meaning of the General Data Protection Regulation.

WHY DO WE PROCESS YOUR INFORMATION?

CIAL will only process your personal data when:

- $1.\ It has obtained your consent to process your personal data for specific, explicit and legitimate purposes; and/or$
- $2. It is \, necessary \, to \, comply \, with \, legal \, obligations \, applicable.$

FOR WHAT PURPOSE DO WE PROCESS YOUR INFORMATION?

When you fill this application form, your data, such as your name, email address, telephone number or address, is collected by CIAL and processed in order to respond to your questions and requests, or to provide information.

If you provide your contacts, CIAL may contact you for marketing purposes relating to its services, provided you have consented to the processing of your personal data for this purpose. If you do consent, you will receive marketing communications by email. However, you may object to this data processing at any time.

The personal data you provide us may also be processed for the purposes indicated at the time the data are collected.

Your consent is essential for CIAL to be able to process your personal data for the purposes described above.

HOW LONG DO WE STORE YOUR INFORMATION?

Our policy is to store your data only for the period necessary to fulfil the purposes for which they were collected. However, in certain cases, we may store the data for longer periods when required by law.

WHAT ARE MY RIGHTS?

At any time, you may:

- 1. Have access to the information.
- 2. Ask for the correction of the information if it is inaccurate or incomplete
- 3. Ask for the erasure of your personal data

As the data subject, you have the right to ask CIAL to erase your data without undue delay, and CIAL is required to erase your data without undue delay for any of the following reasons:

- a) The personal data is no longer necessary for the purpose for which it was collected or processed;
- b) You withdrew your consent to the data processing (in cases in which the processing is based on consent) and there is no other ground for the processing in question;
- c) You object to the processing and there are no overriding legitimate interests that justify their processing.
- $4.\,Ask\,for\,restriction\,of\,processing\,of\,your\,personal\,data.$

As data subject, you have the right to ask CIAL to restrict the processing of your data when one of the following situations apply:

- a) You question the accuracy of the personal data, with a restriction period enabling CIAL to verify its accuracy;
- b) The processing is unlawful; you oppose the erasure of the personal data and instead request the restriction of its use;
- c) If you have objected to the processing, pending the verification whether the legitimate grounds of the controller prevail over your grounds.
- 5. Object to the processing of personal data.
- 6. If the processing depends on your consent, you have to right to withdraw that consent.

If consent is legally necessary to process the data, the data subject has the right to withdraw consent at any time. However, the right to withdraw consent does not affect the lawfulness of any processing based on the consent initially given up to the point of its withdrawal. It also does not affect the subsequent processing of the data based on other legal ground, for example, in the case of compliance with a contractual obligation or with any legal requirements to which CIAL is subject. Your requests will be processed with special care so that we can ensure we give effect to your rights. We may ask you to prove your identity in order to ensure that any personal data is only shared with its data subject.

Please bear in mind that, in certain cases, for example, as a result of legal requirements, your request may not be dealt with immediately.

In any case, you will be informed of the measures taken to deal with your request within one month of the date the request is made.

You also have the right to make a complaint to the Portuguese National Data Protection Commission https://www.cnpd.pt/.

We are committed to keeping your data secure and we use appropriate security measures to ensure your personal data is protected and to prevent access to them by unauthorised persons. We periodically analyse our security systems and policies to ensure that your data is safe and protected. However, the transmission of data over the Internet is not completely secure and we cannot provide an absolute guarantee of the security of the information transmitted through our website.

We also respect the confidentiality of your information. Therefore, we do not sell, distribute or make your information commercially available in any other way, to any third party. CIAL keeps your information confidential in accordance with this Privacy Policy and with the applicable legislation.
